

## TESSENDERLO GROUP: UPDATE REPURCHASE OF SHARES

With reference to Article 7:215 § 1 of the Companies and Associations Code and Article 8:4 of the Royal Decree of April 29, 2019, implementing the Companies and Associations Code, and as authorized by the Extraordinary General Meeting of Shareholders on May 10, 2022, Tessenderlo Group launched a new share repurchase program in early April 2024 for the repurchase of up to 2,300,000 shares of the company for a total amount not exceeding 69 million EUR. As the share price is currently quoted below its book value, as well as taking into account the liquidity position of the group, the Board of Directors is of the opinion that it is opportune to proceed with the repurchase of shares. Between May 6 and May 10, 2024, Tessenderlo Group acquired 43,000 of its own shares at an average price of 24.79 EUR per share, for a total amount of 1,066,078.55 EUR. The transactions took place on the Euronext Brussels regulated market. As a result of these transactions, the company holds 748,950 of its own shares in total, or 0.89% of the total number of issued shares as of May 13, 2024. In addition, the company, through its subsidiary Picanol nv, still holds 21,860,003 of its own shares, or 25.90% of the total number of issued shares (being 84,389,759 shares).
