TESSENDERLO GROUP: UPDATE REPURCHASE OF SHARES

With reference to Article 7:215 § 1 of the Companies and Associations Code and Article 8:4 of the Royal Decree of April 29, 2019, implementing the Companies and Associations Code, and as authorized by the Extraordinary General Meeting of Shareholders on May 10, 2022, Tessenderlo Group launched a new share repurchase program in early April 2024 for the repurchase of up to 2,300,000 shares of the company for a total amount not exceeding 69 million EUR. Between July 1 and July 5, 2024, Tessenderlo Group acquired 121,280 of its own shares at an average price of 23.85 EUR per share, for a total amount of 2,892,974.85 EUR. As a result of these transactions, the company holds 1,242,230 of its own shares in total, or 1.47% of the total number of issued shares as of July 8, 2024. In addition, the company, through its subsidiary Picanol nv, still holds 21,860,003 of its own shares, or 25.90% of the total number of issued shares (being 84,389,759 shares).
