

## TESSENDERLO GROUP: UPDATE REPURCHASE OF SHARES

With reference to Article 7:215 § 1 of the Companies and Associations Code and Article 8:4 of the Royal Decree of April 29, 2019, implementing the Companies and Associations Code, and as authorized by the Extraordinary General Meeting of Shareholders on May 10, 2022, Tessenderlo Group launched a new share repurchase program in early April 2024 for the repurchase of up to 2,300,000 shares of the company for a total amount not exceeding 69 million EUR. Between September 9 and September 13, 2024, Tessenderlo Group acquired 51,000 of its own shares at an average price of 24.57 EUR per share, for a total amount of 1,253,172.75 EUR. As a result of these transactions, the company holds 143,000 of its own shares in total, or 0.23 % of the total number of issued shares as of September 16, 2024.
