

TESSENDERLO GROUP: UPDATE REPURCHASE OF SHARES

With reference to Article 7:215 § 1 of the Companies and Associations Code and Article 8:4 of the Royal Decree of April 29, 2019, implementing the Companies and Associations Code, and as authorized by the Extraordinary General Meeting of Shareholders on May 10, 2022, Tessenderlo Group launched a new share repurchase program in early April 2024 for the repurchase of up to 2,300,000 shares of the company for a total amount not exceeding 69 million EUR. Between October 14 and October 18, 2024, Tessenderlo Group acquired 27,000 of its own shares at an average price of 25.13 EUR per share, for a total amount of 678,562.25 EUR. As a result of these transactions, the company holds 348,287 of its own shares in total, or 0.57 % of the total number of issued shares as of October 21, 2024.
