TESSENDERLO GROUP: UPDATE REPURCHASE OF SHARES

With reference to Article 7:215 § 1 of the Companies and Associations Code and Article 8:4 of the Royal Decree of April 29, 2019, implementing the Companies and Associations Code, and as authorized by the Extraordinary General Meeting of Shareholders on May 10, 2022, Tessenderlo Group launched a new share repurchase program in early April 2024 for the repurchase of up to 2,300,000 shares of the company for a total amount not exceeding 69 million EUR. Between November 4 and November 8, 2024, Tessenderlo Group acquired 17,500 of its own shares at an average price of 24.71 EUR per share, for a total amount of 432,406.60 EUR. As a result of these transactions, the company holds 402,687 of its own shares in total, or 0.66 % of the total number of issued shares as of November 12, 2024.
